**Sub: Participation in ATMA Tests for PGDM/MBA Admissions for academic year 2018-19**

At the outset, I am thankful to all those institutions who have supported ATMA during last year. Because of your whole-hearted support ATMA witnessed great success in terms of no. of registrations, which were about 20,000.

The eighteen year-old ATMA (AIMS Test for Management Admissions) is one of the six (ATMA, CAT, CMAT, GMAT, MAT and XAT) National Level Tests recognized by the AICTE / MHRD, Govt for admissions to MBA/PGDM (and in some states MCA also) courses. The national level status of ATMA has been confirmed by the Supreme Court also during 2011.

**Online Tests**

Starting from **January till August, 2018**, ATMA is planned on the following dates at about 30 cities across the country:

- **Sunday, 14th January 2018**
- **Sunday, 25th February, 2018**
- **Sunday, 27th May, 2018**
- **Sunday, 01st July, 2018**
- **Sunday, 05th August, 2018**

The test results will be announced in about five working days from the date of conduct of the Test. Full data of the examinees with scores will be made available through email to the head of the institution only.

## **About ATMA**

ATMA tests the candidate's verbal, quantitative and analytical abilities. The scores in each of these abilities are supplied to the participating institutions to assist them in the selection process. There are over 200 institutions that accept ATMA scores and they have expressed satisfaction of the quality of the test. They have shown appreciation of the total transparency of the process that we follow.

**We are introducing mock tests with a lot of digital campaigning etc and also revamping the website to make it a mobile friendly, shortly, to further improve the registrations.**
